“RESOLVED THAT, in view of the closure of Business Administration (BBA) and Bachelor of Computer Applications (BCA) programs offered under Bhawanipur College of Creative Arts & Applied Sciences (Erstwhile NSHM College of Management & Technology, Kolkata), the Board hereby approves the transfer and continuation of the said programmes under Bhawanipur Global Campus (An Autonomous Institution) running under the aegis of the Society, effective from the Academic Session 2026-2027.

FURTHER RESOLVED THAT owing to the said transfer as also after reviewing the growing demand for the aforesaid programs offered by Bhawanipur Global Campus (An Autonomous Institution), the proposal for increasing the sanctioned intake capacity for Bachelor of Business Administration (BBA) course and Bachelor of Computer Applications (BCA) course be and is hereby approved to be increased from the existing 120 seats to 510 seats and from the existing 120 seats to 240 seats respectively, both effective from the Academic Session 2026-2027.

FURTHER RESOLVED THAT the Institution possesses the requisite additional infrastructure, faculties and financial capacity to accommodate an increased number of students, in compliance with the norms stipulated by the Regulatory Bodies.

FURTHER RESOLVED THAT Mr. Pradip Sheth who is holding the position of Honorary Secretary in the Society and/or Mr. Jitendra Shah who is holding the position of Honorary Joint Secretary in the Society be and is hereby authorized to make the necessary application to the competent authorities for the aforementioned closure of courses of one college (NSHM College of Management & Technology, Kolkata and increase in intake of courses of the other college (Bhawanipur Global Campus), and to pay all requisite fees and charges.”

“RESOLVED THAT in order to restructure and strengthen the academic portfolio of Bhawanipur Global Campus (An Autonomous Institution), running under the aegis of the Society, the Board hereby approves the decision to close and/or to discontinue the following existing academic programs offered by the college with effect from the Academic Year 2026-2027 also keeping in view that no admission of students were taken for the following programs in the last two academic years i.e. 2024-2025 and 2025-2026.

- A. MBA (Hospital Administration)
- B. MBA (Securities Market)

FURTHER RESOLVED THAT the Board also approves the introduction of two new academic programs in place of the abovementioned discontinued programs, with the same sanctioned intake capacity of 30 seats each, subject to statutory approvals from AICTE, with effect from the Academic Year 2026-2027.

- B. MBA (Health Care and Hospital Management)
